This form is required for all relinquishments (stray or owner give ups). Due to the nature of our donation based funding, PURRS also **requires a relinquishment fee/donation** at the time an animal is turned over to our rescue program. This monetary donation is a minimum of \$50 per cat and is used to cover our costs for your relinquished pet (i.e., medical needs, food, housing, marketing etc.). If you are unable to make this donation or special circumstances apply, please let us know. Donations over that amount are welcome. It takes a minimum of \$100 for us to get a cat ready for adoption.
